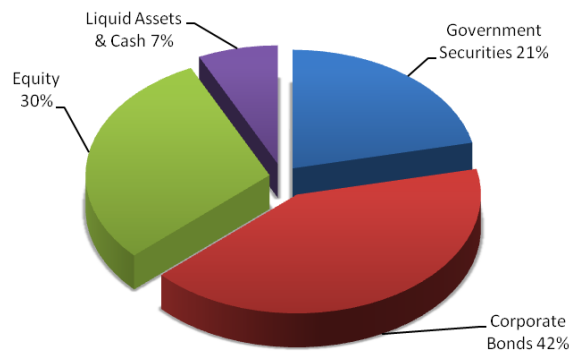

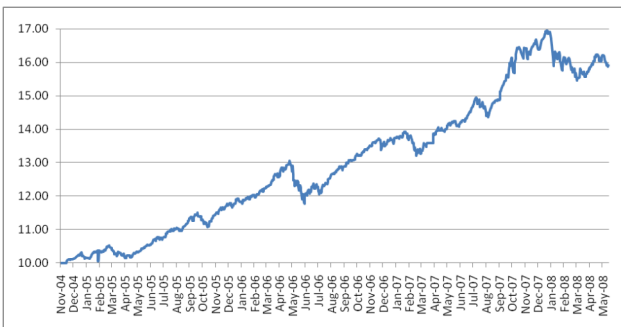

NAV Movement since inception



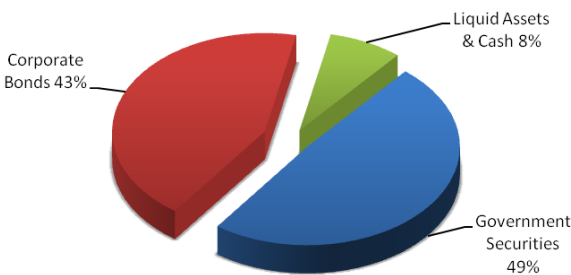

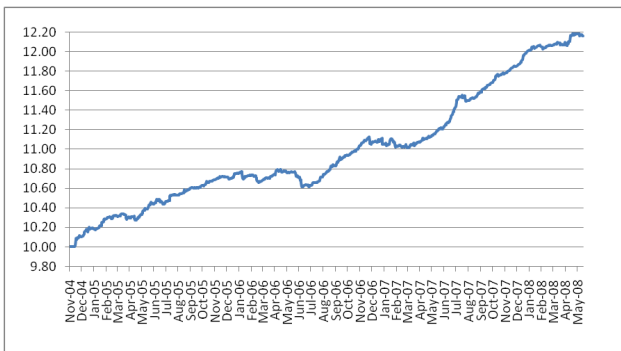
