Asked CM to reconsider cattle law for rural population, says Paatil

VADODARA, MAY 25

GUJARAT BJP president C R Paatil Wednesday said that the party urged Chief Minister Bhupendra Patel to "reconsider" the recent Bill to control stray cattle in cities as it was "inconsiderate" towards the rural population.

The state BJP chief, who had in October last year rebuked Vadodra Mayor Keyur Rokadia for the attacks due to stray cattle, said that the civic body has "enough power" to tackle the issue.

"I have instructed the Mayor to restart the crackdown on stray cattle, which had been done once... To deal with the menace of stray cattle in cities, the civic bodies have enough laws to restrain them. There is no need for additional law,"

Paatil said that the reason he had made a representation to CM Patel after the Gujarat Assembly passed the Gujarat Cattle Control (Keeping and Moving) in Urban Areas Bill, 2022 – aimed at regulating stray cattle in Gujarat's eight major cities as well as 162 towns having Municipalities – was for protecting the "interest of rural population".

Paaril said, "The law would have required even cattle owners in rural areas to secure licenses for having animals. So, based on the representations we received, we requested the chief minister to reconsider the law because for people from villages to get licenses or be fined for having cattle was not feasible. It would not be right to penalise the village cattle owners as per provisions of the law when civic bodies have enough power to tackle their issues."

When told that Rokadia had

Slamming Congress leader Bharatsinh Solanki for his comments on Ram Mandir, Paatil said, "Yesterday, a Gujarat Congress leader made a statement about Ram Mandir and

made it clear that he needs to be taken to a mental asylum for treatment. They should stop playing with the sentiments of Hindu brothers and sisters for I am warning them from this stage that if they attempt to do this again and again, the Hindu brethren will teach them a fitting lesson."

Rs 500 fine if pillion riders do not wear helmets

THE MUMBAI Traffic Police on Wednesday issued a statement alerting all citizens riding a bike to ensure that even pillion riders are wearing helmets, failing which, a fine of Rs 500 will be imposed.

The driver's licence may also be suspended for three months apart from the fine if he is seen riding without a helmet.

The police have given a 15-day window to comply post which they will begin a crackdown. As per sections 129 (wearing a protective headgear) and 194D (punishment for contravening section 129) of the Motor Vehicles Act, traffic police

will impose a fine on bikers driving without helmet.

The driver as well as the pillion rider on a bike will have to wear helmets. We will start initiating action against those not wearing helmets after 15 days," said Raj Tilak Raut, DCP (Traffic/HQ) central, in the press note.

Earlier this year, Traffic Police began cracking down on registering FIRs against those driving in the wrong direction. They also fined over 1 lakh bikers for driving without helmet and put thousands of them through counselling at a traffic division.

It has also sent thousands of proposals in the RTI to suspend licences of bikers driving without helmets.

Day 2 of light rain in Mumbai, cloudy sky forecast for 2 days

FOR the second consecutive day, South Mumbai recorded light rain on Wednesday. More rain is likely in the coming days as a generally cloudy sky with the possibility of light rain or drizzle is forecast for the next two days for the city.

As per the seven-day forecast, Mumbai is likely to witness light rain till the end of May with thunderstorm forecast for next week on May 30 and 31.

While no rain was recorded in the eastern and western suburbs, the southern part of Mumbai recorded 2.8 mm of rain in the last 24 hours ending 8.30 am on Wednesday. High relative humidity at 80 per cent was recorded at the Colaba observatory.

Rainfall recorded at the Santacruz observatory, which is taken as representative of the city, is 0.4 mm. The total rainfall recorded at the Colaba observatory from March 1 is 6.6 mm.

On May 17, 2021, when the extremely severe cyclonic storm

Taukate brushed past Maharashtra's coast, the highest 24-hour rainfall was recorded in the city in May at 230.3 mm.

Following the rain, the minimum temperature recorded on Wednesday was two degrees below normal in the island city. At the India Meteorological Department (IMD)'s Colaba observatory, the night or minimum temperature recorded was 27.5 degrees Celsius.

At the Santacruz observatory, the minimum temperature was 28.9 degrees Celsius.

The day temperature at the Santacruz observatory was also a degree above normal at 34.5 degrees Celsius.

With light rains and north-westerly wind, Mumbai's air quality improved on Wednesday.

The Air Quality Index (AQI) on Wednesday was 67, which falls in the satisfactory category, and is forecast to remain in the satisfactory category.

"AQI of Mumbai indicates 'satisfactory' and is likely to be within 'satisfactory' for the next two days," said the System of Air Quality and Weather Forecasting and Research.

295 cases in Mumbai, highest in 3 months

MUMBAI On Wednesday recorded 295 new Covid-19 infections, the highest in the last three months, while Maharashtra logged 470 fresh cases taking its tally thus far to 78,83,818. However, no death on account of the pandemic was recorded in the state on Wednesday. While Mumbai accounted for the most cases over the last 24 hours at 295, Pune and Thane trailed at 49 and 24 cases respectively.

Mumbai's test positivity rate (TPR) — the number of positive cases detected when compared to the total tests conducted — was at 3.2 per cent. Over the last few days, the TPR in Mumbai has been increasing steadily. It had crossed 2 per cent on May 18.

Following the third wave, on February 12, the TPR had gone below 1 per cent. The fresh cases in Mumbai on Wednesday took its tally of infections to 10,63,571. Of the 295 new patients, 12 are admitted to hospitals. Active cases in the city are currently at 1,531.

The number of daily tests be-

ing conducted in Mumbai continued to remain below 10,000. The BMC carried out 9,100 Covid tests since Tuesday evening, taking the total samples tested so far to 1,70,88,341.

The last time the state had reported over 400 cases in a day was on March 10 when 452 cases were recorded. With no new deaths reported in the state over the last 24 hours, its toll remained at 14,78,771. However, the state's active case count climbed to 2,17,505 Wednesday.

Active cases in the state have been on the rise since April 16 when the number was at 626.

CM intervenes after uproar, asks Speaker to expunge remarks

DEPUTY CHIEF MINISTER Keshav Prasad Maurya and Minister of Opposition Akhilesh Yadav on Wednesday sparred in the UP Assembly and made "personal remarks" at each other, forcing Chief Minister Yogi Adityanath to intervene.

The heated exchanges between Maurya and Sanjaywadi Party took place during the discussion on Governor's speech. After Akhilesh concluded his speech which he hit out at the BJP government over a range of issues — law and order, development work among others — and demanded amendments in the Governor's speech to "reflect the real situation". Deputy Chief Minister Maurya said that he would ensure that the SP doesn't come to power in the state "for the next 40 years".

"Sodak kiste banayai hai, expressway isse lamgha hai, Metro karte banyai... Aisa lagta hai apne har sarkar ko apni upladhli ko barana hai" (You could not get agitated like this. Whatever development we are doing or whatever development was done during your government, it was our duty. A government has the right to cite its achievements), Adityanath told Akhilesh.

Woman, two daughters 'consume poison' during police raid, one dead

A 45-YEAR-OLD woman and her two daughters allegedly consumed poisonous substances when police raided their house in a village in Bagpate late Tuesday evening to arrest her son in a kidnapping case. While one of the daughters (aged 18) died, the mother and another daughter (aged 16) are said to be critical.

According to police, they raided the house of 22-year-old youth after they received information about his presence there. The youth was booked for allegedly kidnapping a 19-year-old Dalit girl on May 3.

The father of the accused youth alleged that police tortured his wife and daughters. "My wife and daughters were brutally beaten by police when they did not find my son at home. There was no lady cap in the police team," alleged the father, adding that he has filed a complaint against six policemen, including the local station in charge.

Police, however, rejected the charge. "We have so far not

found any evidence of wrongdoing by the police team that had gone to the village," Bagpate Superintendent of Police Neeraj Kumar Jadau said after visiting the village on Wednesday.

The SP has, meanwhile, asked an additional superintendent of police-rank officer to probe the incident. Police suspected that the woman and her two daughters consumed poisonous substances fearing arrest. Police claimed to have recovered wrappers of sulphur, a poisonous agricultural fungicide, from the spot.

According to former village pradhan, the house of the youth was locked from the outside when the police team reached the village. "When police started to knock on the house, the woman refused to open the door. The police then entered the house by scaling the boundary wall," the former pradhan said.

Meanwhile, a heavy police force has been deployed in the village as locals protested and refused to cremate the body. They also threatened violent agitation if their demand for probe and arrest of policemen were not immediately met.

Decision on political foray likely by end of May: Naresh Patel

A DECISION on his political plunge will likely be taken by the end of this month, said Patidar leader Naresh Patel in Rajkot Wednesday.
